# 1. Management Report

#### 1.1. Editorial Team

From January 1<sup>st</sup> 2012 three people left the editorial team: Marilyn Deegan stepped down as Consulting Editor, Stéfan Sinclair as Associate Editor and Femke Vandevelde as Reviews Editor. I want to repeat my thanks to all three of them for their valuable contributions to the Journal which I mentioned in my Editorial to issue 27/1.

#### 1.2. Editorial Board

With the aaDH joining ADHO, a fifth category was added to the Editorial Board which now exists of:

- Permanent members
- Officers and Executive Committee Members of ALLC
- Officers, Executive Committee Members and liaisons of ACH
- Executive Committee Members of SDH/SEMI
- Executive Committee members of aaDH

#### 1.3. OUP

On March 13 & 14 I attended the Oxford Journals Days and participated in discussions, workshops and meetings with OUP staff and fellow journal editors.

Due to some internal reorganisations, Sarah Beattie is now running the production of the Journal instead of Alexandra McAuly.

# 1.4. Objectives

The following objectives for the Journal were outlined in an editorial in LLC 26/1:

- 1. LLC will actively solicit contributions and thematic issues which reflect the total field of Digital Humanities with a special interest in cutting edge interdisciplinary research that deliberately crosses the borders of the humanities. LLC's main focus, however, will reside with the textual, visual, artefactual, and performative disciplines.
- 2. LLC will take action to involve more scholars from Asia, South-America, and Africa.
- 3. LLC will introduce the short paper as a new category of submission next to the full paper, the report on research in progress, the book review and the editorial.
- 4. LLC will publish more book reviews and reviews of published digital products and resources as a service to the community.
- 5. LLC wants to develop further as an electronic journal <a href="http://llc.oxfordjournals.org/">http://llc.oxfordjournals.org/</a> alongside the conventional printed version by stewarding accompanying material online. To this purpose, LLC will closely cooperate with OUP and explore the possibilities of joint issues with DHQ.


- 6. LLC wants to interact with its readers more:

  - with face to face meetings with (potential) readers on conferences and gatherings

#### In July 2012 the following objectives were met:

- 1. Following thematic issues are currently in production:
  - DH2011
  - Quantitative dialectology
  - Comparative Literature in the Digital Age
  - Interface: Graduate papers on Technology & the Humanities

Following proposals for thematic issues have been received:

- DH2012
- Computational Models of Narrative
- Computational Linguistics for Literature
- 2. The breakdown of the submitted papers per country in 2012 shows that although most submissions still come from Europe (18), Asia (5) has taken over from the US (2) and Canada (1) as second largest submitting part of the world. There were 2 submissions from the Arab world, and none from Africa, Australia and South America.



3. A thematic issue of short papers by graduate students is in preparation.

- 4. The two published issues of 2012 contained 14 book reviews (vs. 6 in vol. 2011).
- 5. In 2012, LLC and DHQ are collaborating on two publications:
  - A related section of an LLC paper will be published in Open Access by DHQ.
  - The introductory article of a DHQ issue on oral history will be published by LLC.

# 2. Journal Report January-June 2012

# 2.1. Copy

After an impressive amount of submissions in 2011, submissions have gone back to normal proportions and come in slow in 2012. It is expected that the prospected thematic issues will boost these figures in the second half of the year.

# 2.2. Speed

The average time taken between submission of a manuscript and first decision has gone up from under a month in 2011 to 110 days in 2012 with 130 days for a full paper. This is hugely due to the fact that no ready-edited papers of thematic issues are entered in the system anymore. All submissions are now recorded in the statistics which provides more reliant data.

The average time taken between submission of a manuscript and final decision is 136 days with 210 days for a full paper. This is due to the Journal's intensive revision policy.

The average time taken between receipt in production and online publication is 6.4 weeks.

# 2.3. Acceptance Rate

In the first half of 2012 the immediate acceptance rate of original submissions is 57,14%.

60% of the submissions are sent back to the authors for minor or major revisions, with a 100% success.

The overall acceptance rate for 2012 is thus 82,86%.

#### 2.4. Production

# 2.6. Impact Factor

The Impact Factor has dropped from 0.431 (June 2011) to 0.333 (June 2012), which places the journal 101<sup>rd</sup> of the 161 journals in SSCI Linguistics.

This is partly due to the ranking of the Journal in SSCI Linguistics and the broadened scope of the Journal.
